

MARKET REPORT - WEEK 13

BASED ON SALES AND PURCHASES OF VESSELS WEEK ENDED FRIDAY 28TH MARCH 2025.

President Trump continues to try and achieve his economic and peace making targets via threats and tariffs but it's definitely not all going his way, with some countries pushing back with tariffs of their own, and via his attempts to bring about an end to the Russia / Ukraine conflict he is experiencing first-hand how Russia (and its likeminded associate countries like China, Iran and North Korea) have a strong propensity to do something they said or agreed they would not do and then strongly deny they ever did it.... Meantime much of the rest of the world's commerce is sitting on its hands watching to see which of Trump's threats and tariffs are enacted and if he is able to finally put a big enough lid on the Ukraine and Gaza situations for trade to properly restart in those regions.

The dry freight market remains fairly flat and uneventful across all sizes. When the BDI closed on Friday the BCI and BSI had over the week respectively dropped -7.6% and -1.7%, while the BPI and BHSI respectively gained +8.9% and +3.0%, which all combined for the BDI itself to depreciate just -2.5% w-o-w.

We are now just over 2 weeks away from the Easter holidays which this year fall on the same dates for both the Catholic and Orthodox celebrations so we wait to see if there will be a rush of deals beforehand or if we are already in the slowdown period. Reported sales volume for both wet and dry tonnage currently appears weaker (we are reporting just 4 tankers and 10 bulkers) with even Chinese buyers preferring Japanese built tonnage as and when such units are available. It seems that such preference is now more prevalent after Trump threatened to invoke tariffs on Chinese built and owned tonnage calling at US ports.

In the subcontinent recycling markets, although India and Bangladesh have both recently slightly increased their base offer levels, still very few vessels are being offered for final trips to the breaking beaches.
